I. OBJECT OF THE PRIVACY POLICY

II. WARNING TO THE OWNER OF PERSONAL DATA

IX. DATA SECURITY

All information we collect is stored in secure operating environments, not available for public access with privacy and security.

- Use of standard and market methods to encrypt and anonymize the collected data;
- Use of software to protect against unauthorized access to our systems;

- Existence of internal policies for maintaining information security; and

4 – Access to your data;

5 – Portability of your data to another service or product provider, upon express request by the User, observing commercial and industrial secrets, pursuant to §7, art. 18, of Law No. 13,709/2018;

6 – Deletion of data processed with the User's consent, except for maintenance required in compliance with a legal obligation, pursuant to the items of art. 16 of Law No. 13,709/2018;

7 – Obtaining information about the possibility of not giving your consent, as well as being informed about the consequences, in case of refusal;

8 – Revocation of consent, at any time, in relation to all or part of the personal data processed.
